## MINUTES - BOARD OF DIRECTORS MEETING

January 15, 2024

#### I. DETERMINE QUORUM AND CALL TO ORDER

A quorum was met with five out of five Board Members in attendance. The meeting was called to order at 3:08 PM at 3786 Kenwick Trail, Roanoke, VA 24018.

#### II. EXECUTIVE SESSION

A motion was made (Fralin) and seconded (Simmons) to go into Executive Session to discuss a violation. Motion passed unanimously.

After Executive Session, no action was taken at this time. However, it was determined that a clarification may need to be made to the existing rule. A motion was made (Fralin) and seconded (Simmons) to amend the current rule that states "Colored lights are not permitted on the exterior of homes" to add "including exterior doors and storm doors". Motion passed with four in favor and one opposed (Bohannon).
